Dear Student,

The ongoing disruption caused by the COVID-19 global pandemic continues to create enormous challenges for educational institutions throughout the country. While preserving the learning environment, effectively responding to the coronavirus threat and keeping staff and students safe imposes additional costs to both institutions and students.

The Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) was enacted by Congress on December 27, 2020. As a result, Western Area Career & Technology Center Adult Education has been allocated \$61,886 in emergency student aid. This aid will be awarded as Higher Education Emergency Relief Fund (HEERF) II grants. HEERF II provides emergency funding to educational institutions to assist students in need. In 2020, this funding was known as the CARES Act Funding.

Western Area Career & Technology Center has established the HEERF II CRRSAA Emergency Relief Fund to distribute grants to eligible students to help cover expenses related to the cost of attendance or for emergency costs that arise due to coronavirus. Funds may be used for costs incurred on or after December 27, 2020.

• Institutions must make financial aid grants to students, which can be used for any component of the student's cost of attendance or for emergency costs that arrive due to coronavirus, such as tuition, food, housing and utilities, healthcare (including mental health), or child care. Unlike the CARES Act, the CRRSSA requires that institutions prioritize students with exceptional need, such as students who receive federal Pell grants.

- Students must be a U.S. Citizen or Eligible Non-Citizen.
- Students must be enrolled in an academic/technical program approved to participate in Title IV programs.

Students who are enrolled in the Spring 2021 term and meet the following criteria may be considered for these funds:

• Enrolled in an academic/technical program approved to participate in Title IV programs.

• Have a 20-21 FAFSA or 21-22 FAFSA on file with Western Area Career & Technology Center indicating they meet the citizenship requirements.

Additionally, unlike the CARES Act, the CRRSSA requires that institutions prioritize students with exceptional need when awarding HEERF II grants, such as students who receive Pell grants. Western Area Career & Technology Center has defined exceptional need for the purpose of these funds based on two populations:

• First – Federal Pell Grant-eligible students

• Second – All other Title IV eligible students determined to have exceptional need based on the nature of their emergency student aid application.

HEERF II also provides students with the option to use the emergency grant to help assist with outstanding student account balances. Though students are not required to use these funds to pay outstanding balances, they may choose to do so by electing their preference on the HEERF II Student Application.

In order to process CRRSSA funding assistance for students, we ask that all students complete the attached application no later than May 7, 2021. Only active students who are currently enrolled in an academic program approved to participate in Title IV programs during the Spring 2021 term and are in good standing will be eligible to receive a grant. Once we have received your application, we will begin processing funds for eligible students.
