WACTC runs 4-night 16 hour State Safety Certification and a 2 - night 8 hour State Emissions Inspection courses to give technicians the instruction needed to earn State Safety Inspection and/or State Emissions Licenses.



# SAFETY and EMISSIONS CERTIFICATION FREQUENTLY ASKED QUESTIONS



## Q. How long is the course?

The State Safety Certification option runs for (2) two weeks (4) four class periods. Your third week is designed for Tactile testing (by mutual appointments times). You will attend instructional classes Tuesday and Thursday from 5:00 PM to 9:00 PM.

The State Emission Certification option runs for (1) one weeks (2) two class periods. You will attend instructional classes Tuesday and Thursday from 5:00 PM to 9:00 PM. Your emission testing will be done at the conclusion of the second class session.

## Q. How much does it cost?

WACTC is a non-profit institution, so we really try to keep our costs down. The State Emission certification is \$100.00 with proof of registration. The State Safety certification is \$175.00 for Car or Motorcycle. For car AND motorcycle it is \$230.00. Heavy Truck is \$195 with each additional certification \$55.00.

## Q. Are there job opportunities for me when I'm finished?

The offering is specifically intended for automotive technicians aspiring to become PennDot Emission and/or Safety certified. The certifications follow the candidate and are not tied to an employer. This gives the successful graduate the opportunity to move throughout the state of Pennsylvania.
