POSITION GOAL

 Operating Committee, and philosophies consistent with those of the administration and/or designee.

ORGANIZATIONAL RELATIONSHIP

The Part-Time Teacher of the Practical Nursing pprogram is directly responsible to the Health Sciences Supervisor.

The Part-Time Teacher of the Practical Nursing program is also responsible to the State Board of Nurse Examiners and Department of Health Occupations.

QUALIFICATIONS

- Graduate of an approved school of professional nursing.
- Current, valid Professional Nurse License from the Commonwealth of Pennsylvania (or show evidence of obtaining same).
- Minimum of a baccalaureate degree, preferably in Nursing, with experience in Nursing and Nursing education.
- Clinical experience as recent as two years.
- Must possess and maintain the appropriate academic area certification(s) for this program content area as required by the Joint Operating Committee adopted curriculum.

DUTIES AND RESPONSIBILITIES

The essential functions of this position include, but are not limited to the following fundamental duties:

- Honor and protect the confidentiality of student, personnel, and school business.
- Orient students to the clinical facilities.
- Clinical assignments based on student's abilities and concurrent theory.
- Teach, supervise, and evaluate clinical experience.
- Counsel and direct students to help them meet level objectives and ultimately the objectives of the program.
- Teach, supervise, and evaluate students in the clinical laboratory.
- Participate in all faculty meetings and planned activities of the Practical Nursing program.
