

to test. Number 1 DON'T WAIT!! Sit the exam as soon as possible. Take the questions at face value, don't read into them. Most of the questions were teaching, safety, and reinforcement until the end when they were select all that apply.

NCLEX Knowledge Test

1. The Patient Self Determination Act of the United States protects clients in terms of their rights to what? *Select all that apply.*

NCLEX Knowledge Question Answers:

1. **B D** The Patient Self Determination Act, which was passed by the US Congress in 1990, gives Americans the right to make healthcare decisions and to have these decisions protected and communicated to others when they are no longer competent to do so. These decisions can also include rejections for future care and treatment and these decisions are reflect in advance directives. This Act also supports the rights of the client to be free of any coercion or any undue influence of others including healthcare providers.
2. **A**. A lack of oxygen during the birth process is an example of a biological and heredity factor that can influence growth and development.
3. **D**. OBRA (Omnibus Budget Reconciliation Act) states each resident in a long-term care facility is to be at their highest practicable level of physical, mental, psychosocial well-being and must emphasize resident's rights
