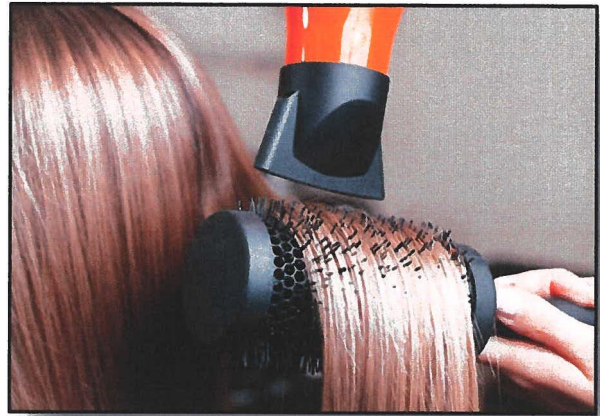

COURSE OBJECTIVE

Students will obtain the education and skills in preparation for the Pennsylvania State Board Cosmetology Examination. Students are eligible to take this exam after completing 1,250 hours in the program.

COURSE DESCRIPTION

Cosmetology is a three-year course for tenth, eleventh, and twelfth grade students. The course will be operated by Western Area CTC under the regulations of the State Board of Cosmetology. Students with outstanding attendance will receive the required 1,250 hours of training needed to take the State Board exams for licensing.

COSMETOLOGY SKILLS

Active Listening - Giving full attention to what other people are saying, taking time to understand the points being made, asking questions as appropriate and not interrupting at inappropriate times.

Speaking- Talking to others to convey information effectively.

Time Management - Managing ones' own time and the time of others.

Coordination-Adjusting actions in relation to others' actions.

Social Perceptiveness- Being aware of others' reactions and understanding why they react as they do.

Reading Comprehension - Understanding written sentences and paragraphs in work related documents.

Learning Strategies - Selecting and using training/instructional methods and procedures appropriate for the situation when learning or teaching new things.

Active Learning- Understanding the implications of new information for both current and future problem-solving and decision-making.

Equipment Selection -Determining the kind of tools and equipment needed to do a job.

Critical Thinking - Using logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions or approaches to problems.

APPROXIMATE COST: \$650

Sophomores entering the Cosmetology program will be notified by mail of a **mandatory** Orientation meeting to be held before the start of the school year. Questions, kit deposits and concerns will be addressed at that time.

NOTE: A charcoal Sport Crew Jacket (Style No. 9808SL) is to be ordered from Gavsonsalon.com. Please make sure when ordering you choose a size that allows for a shirt to be worn underneath and that it is able to be buttoned.

Lockers are provided for students to change out of street clothes into their uniform. Locks must be purchased from WACTC; cost is approximately \$6.

Clinical activities/learning situations may require that any body piercings be removed and any tattoos covered.

Students may be required to wear professional clothing for vocational student organization conferences, competitions and meetings.
